

No PNC Bank report was forwarded by the City of Zion for May 2012. Attorney Flaherty stated a letter was sent the City of Zion's Attorney indicating the Bank statements must come to the Newport Township FPD Board monthly. Attorney Flaherty is waiting for a reply.

## **Payment of Bills:**

- Board discussion regarding the status of an agreement with the Beach Park FPD regarding their Station # 2.
  Chief Kirschhoffer was requested to set a meeting date of both Boards to discuss the mutual interest in the Major Avenue fire station.

• Motion by Trustee Stanonik to move the monthly Board of Trustee meetings to the 2<sup>nd</sup> Wednesday evening of the month at 7 pm. Second by Trustee Brewer with discussion. The Board feels moving to evening meetings will allow more residents to attend. The 2<sup>nd</sup> Tuesday of the month will not conflict with other Village or Township meetings in Newport Township. A roll call vote was called by President Stanonik with Trustee Stanonik AYE, Trustee Reno AYE and Trustee Brewer AYE. With no NAY vote the motion carried.
