

Meeting Minutes of the Board of Trustees of the Newport Township Fire Protection District Meeting Date June 21, 2011

Meeting Called to Order:

• The June 21, 2011 Board Meeting of the Newport Township Fire Protection District was called to order at 8:00 am by Board President Stanonik. The meeting was held at the Newport Township Fire Station and publicly posted.

May 17, 2011 Board Meeting Minutes;

• Trustee Stanonik moved to approve the May 17, 2011 meeting minutes seconded Trustee Campanella with discussion. Trustee Campanella pointed out the April 31, 2011 and year end Zion and Newport joint account amount still not correct in the minutes and must be corrected to approve. Chief will have corrected with Auditor approved figure for the July meeting. The motion is tabled until the July meeting.

• Trustee Stanonik moved to approve the June 9th, 2011 budget workshop special meeting minutes as presented. Seconded by Trustee Campanella with a roll call vote indicating Trustee's Stanonik, Campanella and Reno AYE and no NYE vote. Motion approved.

Payment of Bills:

• Trustee Stanonik motioned to pay the paid payable listing dated 6/1/11 to 6/15/11 totaling \$43,777.87 and the additional June 16th, 2011 payables totaling \$3,468.10. Trustee Campanella seconded the motion. A roll call vote was followed indicating Trustee Stanonik, Trustee Campanella and Trustee Reno all voting AYE and no NYE vote. Motion to pay the bills approved.

- Attorney O'Conner reported to the Board the Lake County Forest Preserve District refused the sale offer for fire district property located at the corner of Crawford and Stateline Roads. The Forest Preserve District will have the land appraised and submit a counter offer to the Fire Protection District.
- Trustee Campanella excused himself from the meeting at 10:05 am due to a prior business engagement. Motion Trustee Stanonik to appoint Trustee Reno as Secretary Pro Tem for the remainder of this meeting. Second to the motion Trustee Reno with a roll call vote. Trustee Stanonik and Trustee Reno AYE and Trustee Campanella absent. Motion carried.

- Review the proposed Life Safety Ordinance as presented by Fire Marshal Brewer. Motion by Trustee Stanonik to adopt Life Safety Ordinance 2011-01 as presented. Seconded by Trustee Reno with a roll call vote indicating Trustees Stanonik and Reno AYE and Trustee Campanella absent. Motion Carried.
- Motion by Trustee Stanonik to adopt the 2011
 Prevailing Wage Ordinance as presented by Attorney
 O'Conner. Seconded by Trustee Reno with a roll call
 vote indicating Trustee Stanonik and Reno voting AYE
 and Trustee Campanella absent. Motion carried.
- Review for acceptance the 2011 Village of Gurnee dispatch contract for 2011. Motion Trustee Stanonik and seconded Trustee Reno with a roll call vote indicating Stanonik and Reno AYE and Campanella absent. Motion carried and the Trustees signed the contract for return to Gurnee.
